3 To Suspend Proceedings – Mr Tom James, Mon CC Area Services Officer Abergavenny re: Caldicot Market

The Mayor welcomed Messrs Tom James and Alan Browne to the meeting.

Mr James stated he was undertaking a review of markets in Monmouthshire in order to formulate a report on the future of markets and welcomed Town Council's views on the matter.

The following items were discussed:

- Survey of public and traders undertaken at all Monmouthshire market sites
- Previously each town managed its own market
- What does Caldicot market mean to Town Council?
- Feasibility of outsourcing the running of markets no plans to outsource markets at present
- Caldicot market more popular on Tuesday than Saturday
- Saturday market -7 stalls [average] compared to 17 on Tuesdays [average]
- Markets provide social interaction and low cost produce
- Caldicot market profitable to Mon CC
- Markets create increase in footfall to town centres
- Generally people buy food products from markets
- Concerns expressed re: competition for existing traders in the town
- Stall costs: £12.50 £47.00 depending on size compared to average shop rates
- Standard of facilities in the town
- Identified need to work with Tourism department
- Possibility of more involvement with local farmers?
- Farmers appear to want to work with like-minded rather than general markets
- Farmers' market held at Caldicot Rugby Club failed due to lack of interest possibly not the most suitable location
- Farmers tend to gravitate to larger farmers' markets
- Continental market held in Town Centre in past
- Craft markets
- Markets important to communities they serve

Members noted the report would be made available around September 2011.
