# 9057 To Consider draft Agreement Caldicot Town Council/Caldicot Town AFC [Circ]

Town Council considered the draft Agreement as circulated which had been drawn up by the Mayor.

The Mayor stated that he and Cllr D Evans, as a member of the User Committee, had met with Caldicot AFC for discussions and Caldicot AFC were happy to accept the draft Agreement he had drawn up.

A Member requested clarification regarding responsibility for the management of the enclosed pitch. The Clerk referred the Mayor to the Agreement for Caldicot AFC Use of KGVPF in 2004, *ie "The Management of the KGVPF remains the responsibility of the Town Council but the management of the enclosed pitch itself will be the responsibility of the Caldicot Football Club"*. The Mayor offered his personal view in this matter which contravened the above Agreement and which was supported by other Members.

A discussion ensued and it was considered Caldicot AFC should not have to be responsible for litter picking the enclosed area when it is open to the public.

The Clerk advised Town Council that if Caldicot AFC was no longer going to be responsible for the management of the enclosed pitch, Town Council would currently have nobody to clear the area as the Agreement with Caldicot AFC had been in place since 2008 and had never formed part of the contract groundsman's contract.

#### It was resolved:

- i) to accept the draft Agreement as the terms and conditions under which Caldicot Town AFC are allowed to utilise the KGVPF.
- ii) to request quotation from the contract groundsman for litter picking the enclosed area on a daily basis.
- iii) that the Mayor and Chairman, Caldicot AFC sign the Agreement
